Discharge of Liquid Trade Waste Approval Process

To the Manager/Business Owner

Please find attached application forms for the discharge of Liquid Trade Waste to Council's Sewerage System.

Liquid Trade Waste is liquid waste produced by a business, commercial or industrial activity. It excludes domestic waste from a hand wash basin, shower, bath or toilet.

It is a legal requirement for any business that discharges liquid trade waste to the sewer to have an approval to do so. Even if your business already has some form of pre-treatment device (e.g. grease arrestor or oil separator), it does not mean an approval has been issued.

Council is in the process of inviting all businesses to lodge an application for approval. Please fill in the attached forms as best as possible and submit them to Council.

There is a fee involved with this application, currently \$107.00 for new applications, \$53.00 for renewal applications. (As per Revenue Policy 2024/2025)

- 1. Council will assess the application in accordance with the requirements of Section 68 of the Local Government Act 1993.
- 2. Council may within twenty-one (21) days of receipt of the application request an applicant to provide it with more information that is reasonably necessary to enable the proper determination of the application in accordance with Section 86 of the Local Government Act 1993.
- 3. The application must be accompanied by the appropriate fee paid in accordance with Section 80 of the Local Government Act 1993 and Council's Management Plan.
- 4. Council will acknowledge receipt of valid applications in accordance with Section 84 of the Local Government Act 1993.
- 5. Unclear or illegible applications will be rejected in accordance with Section 85 of the Local Government Act 1993.

6. Prohibited substances

The following substances are prohibited from being discharged into the sewerage system. If there is any doubt, please contact Council.

- organochlorine weedicides, fungicides, pesticides, herbicides and substances of a similar nature and/or wastes arising from the preparation of these substances;
 organophosphorus pesticides and/or waste arising from the preparation of these substances
- any substances liable to produce noxious or poisonous vapours in the sewerage system
- organic solvents and mineral oil
- any flammable or explosive substance
- discharges from 'Bulk Fuel Depots'
- chromate from cooling towers
- natural or synthetic resins, plastic monomers, synthetic adhesives, rubber and plastic emulsions
- rain, surface, seepage or subsoil water, unless specifically permitted
- solid matter
- any substance assessed as not suitable to be discharged into the sewerage system
- waste liquids that contain pollutants at concentrations which inhibit the sewage treatment process refer Guidelines for Sewerage Systems: Acceptance of Trade Waste (Industrial Waste) (ARMCANZ/ANZECC, 1994)
- any other substances listed in a relevant regulation
