

# Summary of decisions

## February 2023

### Council Meeting



- At the request of Business Cowra, Council deferred signing the MOU until such time as Business Cowra has undertaken a review of their operations and provides advice to Council on the outcome of that review.
  - Council noted the cost estimate received from NSW Electoral Commission for the 2024 Local Government Election.
  - Council will register with Reconciliation Australia to develop a Reconciliation Action Plan (Reflect) under their established framework. The Reconciliation Working Party will remain in place to guide the process and report to Council as required.
  - Council will establish a CBD Working Party to consider options for the establishment of a CBD Committee and report its findings and recommendations back to Council. Councillors D'Elboux, Downing, Watt, West and P Smith were appointed to the CBD Working Party.

- Council noted the Investments and Financial report for January 2023.
  - Release of Closed Decisions: 10/23 – Heavy Patching and Mini Rehabilitation Services – acceptance of tenders from RoadWorx Surfacing Pty Ltd and Kerway Ashphalting Pty Ltd.
  - Council noted the minutes of the Cowra Regional Art Gallery Advisory Committee meeting held on 14 December 2022.

- Council reviewed Development Application No. 74/2022, Lot 1 DP 129507, 43 Young Road Cowra, Section 8.3 review of DA 74/2022 for advertising signage, lodged by K Malouf and noted that the reason for the decision is that the proposal is not considered appropriate with respect to Section 4.15 of the Environmental Planning and Assessment Act 1979.
  - Council endorsed the public exhibition of the Cowra Shire Swimming Pool Inspection Policy for 28 days. Following the public exhibition, the Director of Environmental Services will re-submit the Policy to Council for formal adoption.
- Council approved the creation of an easement for access 5.1m wide over the carpark aisle shown on plan No. 44/2020(A); Development Consent No. 44/2020; to provide legal access to Lot 2 DP 124692 (29 Liverpool Street) to Rowston Lane.
  - The minutes of the Traffic Committee meeting held on 13 February 2023 were noted.
  - Council approved the Class 3 special event to be held on 9 - 11 March 2023 subject to compliance with the requirements of Transport for NSW (TfNSW) and NSW Police.
  - Council approved the Class 2 special event to be held as part of the ANZAC Day Parade on 25 April 2023 subject to compliance with the requirements of Transport for New South Wales (TfNSW) and NSW Police.
  - Council will check Holmwood School Zone signage for compliance by TfNSW and will contact the principal of Holmwood School to seek further details of the Ministerial complaint regarding the Holmwood School Zone. Council will place traffic counters within the school zone in front of Holmwood School to collect relevant data.
  - Council received and noted the information provided on the projects to be nominated to the 'Natural Disaster Relief and Recovery' additional \$1M grant program.
