- Council moved to amend the 2022/23 Water Supply Capital Works program in the draft 2022/2023 Operational Plan.
- Development Application No. 109/2020, Lot 1 DP 801755, 2 Lachlan Street Cowra, change of use of commercial premises to service station including alterations & additions, lodged by O M Investment Pty Ltd was approved with conditions.
- Council will write to the NSW Planning Minister,
  the Shadow Minister and local member
  expressing the major concerns Council and the
  community are having with the NSW Planning
  Portal and urging the Government to either
  abandon the portal or make urgent changes to
  improve its operation for Council staff and the
  community. Council supports Central NSW Joint
  Organisation's advocacy on this matter and will
  consider submitting a motion to the upcoming
  LGNSW Annual Conference on this matter.
