

# Summary of decisions

## March 2022 Council Meeting



- Mayoral Minute - Council supported the national funding priorities of the Australian Local Government Association (ALGA) and will participate in the ALGA's advocacy for their priorities by writing to the local Federal Member of Parliament, candidates for Riverina and the President of the Australian Local Government Association to: express support for ALGA's funding priorities; identify priority local projects and programs that could be progressed with the additional financial assistance from the Federal Government being sought by ALGA; and seek funding commitments from the members, candidates and their parties for these identified local projects and programs.

- Council signed the Cowra MRF Glass Hardstand Agreement with Cleanaway Waste Management Limited.
  - Council noted the minutes of the March meeting of the Traffic Committee and approved the following:
    - Erection of "No Stopping" signs on the southern side of Comerford Street;
    - A review of the Speed Zone for Bonnie Braes Road will be referred to Transport for New South Wales (TfNSW);
      - Reduce speed curve advisory signs will be installed on the curves on Pride of Oak Road 300m west of Wianamatta Road and on Wianamatta Road 950m north of Pride Of Oak Road;
      - A "T" intersection notification sign on Wianamatta Road be relocated between 60-80m north of the intersection;
      - A "No Through Road" sign will be erected at the southern end of Wianamatta Road;
      - Speed zoning of Pride of Oak and Wianamatta Roads will be referred to TfNSW for review.
      - The route of the Class 2 special events Festival of International Understanding Street Parade on 2 April 2022 and the ANZAC Day Parade on 25 April 2022, subject to compliance with the requirements of TfNSW and NSW Police.
      - A Speed Zone Review on the location of the 50km/h and 80km/h speed zones on Grenfell Road east of Airport Road, Cowra has been recommended to TfNSW.
      - Council noted that TfNSW will assess MR56 South (Boorowa Road) to determine if signage improvements are necessary in the vicinity of the rural bus stop at Anderson Lane.

- Council adopted the Policy Review of Section 355 Committees.
- Council noted the resignation of Mr Ray Walsh as one of the two Council appointed delegates to the board of Cowra Tourism Corporation. Council appointed Cr Ruth Fagan to be Council's second delegate to the board of Cowra Tourism Corporation. Council will write to Mr Walsh thanking him for his contribution to Cowra Tourism Corporation.
- Council allocated funding under Cowra Community Grants Round 2 2021-2022.

- Council noted the minutes of the December and February meeting of the Cowra Regional Art Gallery Advisory Committee. Council appointed Linda Chant to the Committee and will write to Jack Mallon expressing gratitude for service to committee.
  - Council donated \$154 to Twilight Tens for waste disposal, bin hire and waste collection; \$2,747.50 to the Cowra M&D for the 'Showcase Cowra' production; and \$1,500 to the Cowra Men's Shed for change of locks at premises.
  - Council noted the Investments and Financial Report for February 2022.
  - Council noted the report on IPART's Additional Special Variation Process.
  - Council noted the minutes of the March meeting of the Audit, Risk & Improvement Committee (ARIC). Council will formally thank Mr Andrew Fletcher for service to ARIC and seek advice from NSW Government regarding recovery of pandemic costs.
  - Closed Council Decisions from the February meeting were released.
  - Council will write to the families of the late Bill Bundy and Max Tomlin expressing condolences on their loss and acknowledging their contributions to the Cowra community.
