- Pursuant to section 296(3) and (5A) of the Local Government Act 1993 [the Act], the Electoral Commissioner entered into contracts with the following councils for the Electoral Commissioner to administer all elections of the council:

 - Berrigan Shire Council Cowra Shire Council Junee Shire Council Lachlan Shire Council
- On 14 August 2024, nominations closed for candidates for the general local government elections to be held under the Act on Saturday, 14 September 2024, Fewer candidate nominations than the number of councilions required were received for Berrigan Shire Council, Cowra Shire Council, Junee Shire Council and Lachlan Shire
- Pursuant to section 291 of the Act, if a casual vacancy occurs in a civic office, the office is to be filled by a by-election, subject to the provisions of Chapter 10 Part 5 of the Act

Council (E Ward), and casual vacancies on each council have ensued

- 4. Fursuant to section 292 of the Act, a by-election to fill a casual vacancy is to be held on a Saturday that falls not later than three months after the vacancy occurs and, in relation to an election administered by the Electoral Commissioner, the date for the by election is fixed by the Electoral Commissioner.
- 5. I fix the date of Saturday, 23 November 2024 as the date for the conduct of the byelections to fill the casual vacancies on the above councils, to be conducted by returning officer appointed by me under section 295(2) of the Act.
